Duration 23 weeks: 19 weeks (2 days per week), with a further 4 weeks (5 days per week) staggered throughout the program, equalling 150 hours practical placement.

## Is this course for me?

Become a valued and integral part of the health and community sector and make yourself highly-employable as a Care Worker with Greenhouse Education's CHC33015 Certificate III in Individual Support. The Certificate is perfect for people who are wanting to start a career as a Care Worker, as well as for those who are already working in the area but who need to formalise their qualifications in order to take the next step in their career. Throughout your training, the focus will be on empowering you with the knowledge and competencies required by Individual Support workers to deliver individualised person-centred support to people who may require assistance due to ageing in community or residential based settings.

Through theory and practical course work you will learn to:

- Provide individualised support to clients
- Empower clients to reach their independence goals
- Work with a range of diverse clients, including people with dementia
- Provide information and advice to clients on their oral health
- Provide person-centred support
- Use discretion and judgement in a variety of settings

## Entry Requirements

There are no set pre-requisites for this qualification, however; you must show:

- A satisfactory level of language and literacy skills, which will be established at the time of enrolment
- A genuine desire to work in the Individual Support industry
- Immunisation record and current Influenza vaccine
