This course is the foundation qualification for all Childcare Professionals. It is an essential stepping stone to a meaningful career for people with a natural affinity and interest in the development and education of young children. This course encompasses child development, the importance of Educator and family partnerships, and develops a sound knowledge of the major curriculum learning areas. It will provide you with the practical experience and theoretical knowledge required in an Early Childhood Education and Care setting.

# Entry Requirements

There are no set pre-requisites for this qualification however; you must show:

- A satisfactory level of language and literacy skills, which will be established at the time of enrolment
- A genuine desire to work in the Early Childhood Education and Care profession
- COVID-19 Immunisation Record and Working With Children Check is a part of the practical requirements.
